  4. I hereby certify that the boat entered is insured and has valid liability cover for not less than \$10 million and will ensure that this cover remains current throughout the entire series.
  5. I will be bound by the RRS of the ISAF and the Australian Sailing Special Regulations Part 2 for Off the Beach Boats, the prescriptions and safety regulations of Australian Sailing and by the Notice of Race and Sailing Instructions for this regatta and acknowledge that Rule 4, Decision to race, states that "*The responsibility for a boat's decision to participate in a race or to continue is hers alone.*"
  6. I agree to comply with the Code of Conduct of the Hartley TS16 Association of Australia Inc.
